3. Enable the learners to become knowledgeable about IPR licensing and assignment, and comprehend how IPR portfolios can be marketed and protected.
4. With the guidance of qualified and experienced faculty members and professionals, this multidisciplinary course was created to give participants a better understanding of intellectual property with a focus on intellectual property management.
5. Interpret the long conflict between privacy norms and technological advancement through historical and ethical lenses.
6. Help the learners to learn about the different types of data i.e. personal, sensitive or otherwise, the relevance of data protection and privacy.
7. Learning about the disputes and litigation that can arise in data protection and privacy laws and how to deal with them.
