## **General terms and conditions**

1. All annexure and enclosures are essential and integral part of this Tender Document.
2. In these Document, the terms (i) Buyer denotes a person (which expression includes an Individual/Registered Society/Partnership Firm/ Corporate Body) who submits the quotations/bids in response to the above mentioned Notice Inviting Applications (ii).
3. "As-Is-Where-Is" basis only and the principle of caveat emptor will apply. As is where is means that the description/quality/quantity indicated are approximate and the NITTTR, Kolkata authority does not give any assurance or guarantee that the material will strictly adhere to the advertisement. All items shall be taken delivery of from the site by the successful bidders, with its faults and errors in description, if any. Neither can the sale be invalidated nor the bidder make any claim/compensation, whatsoever, on account of any defect in description or deficiency in the quantity and quality. No plea of misunderstanding or ignorance of conditions put forth subsequent to a confirmation of sale shall be accepted.
4. Bidders are instructed to quote rates only after inspection of items at the site. The bidders or his/her authorized representative may inspect the obsolete materials as per of items at the site. The bidder or his authorized representative may inspect the materials as per the inspection schedule mentioned in the auction details, between 11 am to 4 pm (excluding lunch hours 1.30 p.m. to 2.00 p.m.).
5. NITTTR, Kolkata authority reserves the right to accept/reject and cancel any bid/issue of acceptance letter/sale order/delivery order/deposit of the full sale value by the bidder, without assigning any reason thereof and the value of such material, if paid for, shall be refundable. NITTTR, Kolkata authority shall not be responsible for damage/loss to bidders on account of such withdrawal at any stage from the sale.
6. Any statutory variations in the rate of taxes/duties are to be borne by the purchaser. GST rates indicated in the Tender advertisement if any are only indicative and the actual GST rate as applicable on the date shall be payable by the successful bidders directly to Director, NITTTR, Kolkata at the time of taking delivery of materials.
7. Bidders shall have to furnish bid security (EMD) by way of Demand Draft in favour of Director, NITTTR, Kolkata, payable at Kolkata, along with their bids. 10. The bid of the highest acceptable responsive bidder shall have to be accepted based on the total quoted value for all obsolete articles and an acceptance order will be issued. However, if the price offered by the bidder is not acceptable, the negotiation may be held only with next highest responsive bidder.
11. In case the selected bidder does not show interest in depositing the balance sale value or in lifting the obsolete goods within 30 days from the date of awarding of acceptance letter, the bid security will be forfeited and other actions initiated including resale of the obsolete goods in question at the risk and cost of the defaulter
12. The highest responsive bid accepted by the Institute shall remain valid for 45 days from the date of issue of acceptance letter.
13. Rate should be quoted for all the obsolete articles as mentioned in the tender booklet otherwise the bid will be treated as unresponsive and liable for cancellation.
14. The acceptance letter will be issued to the successful bidder(s) notifying the amounts and schedule of submission of Security Deposit and Balance Sale Value.
15. Successful tenderers, herein after referred to as purchase(s), shall have to submit Security Deposit @ 5 (Five) per cent of the total sale value of the contract within seven calendar days of the issue of the acceptance letter (excluding the date of issue). The Security Deposit shall be deposited in the form of bank draft/pay order, drawn on any of the commercial bank in favour of Director, NITTTR, Kolkata.
16. Delivery Order will be issued to take delivery of the material from the custodian and therefore after depositing Balance Sale Value
17. Delivery has to be taken within 30 (Thirty) calendar days from the date of the acceptance letter excluding the date of issue of acceptance letter. The delivery of material will be given only after realization of the demand draft/pay order. If the purchaser is not able to lift the material with the delivery period, he may request for an extension. Such extension will be granted for another 15 (Fifteen) days after levying a ground rent @ 0.5 percent of the sale value per day.
18. The items shall remain, in every aspect, at the risk of the buyer from the time of acceptance of his/her offer. The seller will not undertake any liability whatsoever for the safe custody, protection or preservation after the sale has been confirmed. Lots are put up for sale, subject to change by nature's wear and tear. No complaint regarding the quality or description of the materials sold will be entertained once the bid has been accepted.
19. No picking, choosing, sorting, welding, cutting or breaking of goods or materials sold will be permitted unless otherwise specified. The Buyer shall not be entitled to re-sell an item, lot or part of a lot while the goods are still lying within the premises of the seller and any such sale or assignment of the buyer's right to the material sold in an auction will not be recognized. All documents for releasing materials will be made out in the name of the buyer only.

20. The material will be delivered only to the successful bidder or his authorized representatives or an agent to accept delivery, the bidder shall produce a suitable power of attorney or authorization letter for each lot separately duly attested by a notary public authorizing his representative or agent to lift the material from the seller.
21. NITTTR, Kolkata authority will not be, in any way, responsible for failure to deliver the material due to causes beyond its control such as a strike, lockout, cessation of work by labourers, shortened hours, act of God or other causes or other contingencies whatsoever.
22. Materials sold but not removed within the specified date will become the property of the NITTTR, Kolkata and the Institute shall have the right to dispose of such goods in any manner as he deems fit without any notice.
23. All materials sold shall be weighed/counted before delivery, under the supervision of

  3. Representative of the purchaser
24. Submission of a application will be the conclusive proof of the position that the bidder agrees to abide by all the terms & conditions contained in the Tender documents, and in future the successful bidder thereby irrevocably binds himself to comply the instruction & general conditions framed by the NITTTR, Kolkata during the course of all future dealings in this regard.
25. If there is a variation available quantity at the time of delivery, the actual quantity may vary from the quantity mentioned in the delivery order. In case of excess available material, the Institute reserves the right to retain material in excess of quantity in the lot at its discretion. The purchaser may be allowed to lift the additional quantity after making the requisite additional payment to the seller but if the quantity in a lot count is less than the announced quantity, the Institute will not make good the deficiency under any circumstances. The purchaser thereof will be entitled to obtain a refund for the undelivered quantity at the quoted rate. No interest will be paid on the amount of short delivered quantity.
26. The Institute's responsibility ends after the consignment has been loaded and handed over to the representative of the purchasers. The Institute will be no party to any dispute that may arise after the loading has been completed.
27. NITTTR, Authority shall disqualify the successful bidder, if it finds at anytime that the performance of the purchaser is unsatisfactory and in such cases the decision of NITTTR, Kolkata authority will be final & binding.
28. NITTTR, Kolkata authority reserves the right to cancel the whole or part of the tender without assigning any reason.
29. Decision of the NITTTR, Kolkata authority on selection of the highest successful bidder, acceptance and rejection of part or all Quotations shall be final & binding.



30. The successful bidder shall have to accept the order unconditionally. The contracts shall be incorporated in accordance with the laws of Union of India and subject to the jurisdiction of Kolkata High Court.
31.
